Unidata wins the tender for the Consorzio ASI Bari, worth 3.5 million euros, for the upgrading of the industrial *cluster*

Rome, 23 July 2020 - Unidata S.p.A., a telecommunications company listed on AIM Italia and always focused on the provision of telecommunications services and infrastructure to industrial districts, reports that on 21 July 2020 it received a communication, in accordance with Articles 29 and 76 of Legislative Decree 50/2016, from the commissioning body "Consorzio per l'area di Sviluppo Industriale di Bari" regarding the notice to tender for activities 1, 2 and 3 of the project "*Secure Zone Video Surveillance and environmental monitoring. ASI Industrial Agglomerate of the province of Bari*" (covering the Bari-Modugno and Molfetta cluster) informing of "*the approval, in accordance with Article 33 of Legislative Decree 50/2016, of the proposal of the bidding committee made during the public hearing on 14/07/2020, in favour of participant no. 2, RTI "UNIDATA", consisting of UNIDATA S.p.A. (agent) and Cogepa Telecommunications S.p.A. (principal), represented by the agent UNIDATA S.p.A.*".

The commission is worth approximately 3.5 million euros.

The work tendered for consists of the establishment of a video surveillance and monitoring system for access points by means of the installation of video cameras, a monitoring and control centre and connection to the national SCNTT system for vehicle transit and numberplate recognition.

The time period for Unidata's intervention is approximately 9 months from the start of work, which is scheduled for September 2020.

The contract will be entered into after the 35-day appeal period following the awarding of the tender.

Unidata S.p.A. is a telecommunications company with a strong presence in Rome and the Lazio region. It was founded in 1985 by three partners who remain in post. With a fibre-optic network of more than 2,250 km and constantly expanding, a wireless network and a proprietary data centre, it supplies over 6,500 business, wholesale and domestic customers with ultra-broadband connectivity services using FTTH (Fibre to the Home) network architecture, wireless connectivity, VoIP, cloud services and other dedicated solutions, with a high level of reliability and security. Other activities in the startup phase include the Internet of Things (IoT), with the development and provision of home automation and Smart City solutions.
